

### **Foreword**

#### Dear fellow citizens,

Many private households and companies are currently facing significant additional financial burdens. And waste management isn't spared from these trends. After three years of unchanged waste fees, a fee increase is unfortunately unavoidable from 2024. Numerous factors and events have contributed to this situation. On the one hand, prices that were calculated in the last Europe-wide tender for the collection and transportation of waste are around 30% over the current prices. And the extreme rise in energy and fuel costs, the high inflation rate, the constantly increasing legal



requirements for biodegradable waste processing and especially the newly applicable carbon tax are causing prices in all sectors of waste management to skyrocket.

This means that, despite the release of a substantial provision for fees of 2.8 million euros that we were able to generate in recent years, the fees for nearly all containers are going to rise.

A waste sorting analysis carried out in Kaiserslautern county in 2022 showed that biodegradable waste from most households is high quality. But there is potential for improvement – foreign matter like glass, plastic or metal had been mixed with organic waste. These materials have to be sorted out at great technical effort, which likewise leads to avoidable costs.

The separate collection of biodegradable waste is of enormous economic and ecological importance. There is no other area where regional material circulation loops can be closed more effectively. Reintroducing organic waste into the natural material cycle by recycling and reusing it as a high-quality fertilizer and humus is the most efficient way to increase soil fertility. Besides the sustainable protection of climate and resources, better waste separation reduces the quantity of non-recyclable waste! This in turn helps to save on costs for waste incineration, which has a stabilizing effect on waste disposal fees.

Last year, school classes, communities, associations, and even private individuals initiated and conducted various campaigns where volunteers collected litter in the county. This shows a continually increasing environmental awareness. I'd like to offer thanks to you all – your firm commitment to collection campaigns and waste separation makes a huge contribution to climate protection and keeping our natural environment tidy.

#### THE FOLLOWING SERVICES ARE **INCLUDED IN THE ANNUAL FEE:**

- Provision of cans, removal and disposal of non-recyclable waste, biodegradable waste and waste paper
- Collection and disposal of old electrical appliances
- Bulk waste collection
- Battery collection points

- Dumping of garden waste/clippings at the dedicated collection points
- Disposal of hazardous waste at the hazardous waste truck ("Umweltmobil") and at the ZAK recycling center (see pages 18 and 19)
- Disposal of recyclables in household quantities at the ZAK recycling center in Kapiteltal and the Kindsbach recycling center (see pages 26 and 27)

### Non-recyclable waste

The black can is emptied every 14 days.

Please place the can with the lid closed at the curb before 6 a.m. on the collection day. Overfilled or incorrectly filled cans will not be emptied.

Each household receives their own can for non-recyclable waste unless a joint disposal arrangement has been made. Calculation examples for joint disposal can be found in the following table. The application form for joint disposal is available on our website: **www.kaiserslautern-kreis.de/abfallwirtschaft**

The minimum volume for non-recyclable waste (minimum black can size) depends on the number of household members – see table below.

#### Please note:

- When moving in or out, please contact the Resident Registration Office as soon as possible.
- Do not take waste cans with you when you move. Each can has an identification number and is assigned to a specific lot.
- For persons who are not required to register – e.g. members of the armed forces – the home owner must notify the waste management office (see page 32 under "Contacts" "ALLOCATION FOR HOUSEHOLDS").
- If something changes with regard to ownership (new owner, different address, etc.), the waste management office of the county administration must be informed in writing.
- If the volume for non-recyclable waste is insufficient or if you have recently moved in and are waiting for the black can to be provided, you can use the specific non-recyclable waste bags permitted in Kaiserslautern county and leave them tied up ready on collection day. These bags are available from your local municipal administration or the citizen center of the Kaiserslautern county administration.
- Please also inform the waste management office (allocation division) of the county administration promptly in case different last names are used by people living in the same household. Otherwise each person with a different last name will be considered a separate household and receive their own non-recyclable waste can.

### WHAT GOES IN THE BLACK CAN?

#### **Expired medication**

#### **Toiletries**

Sanitary pads, diapers, toothbrushes, cotton pads and swabs, cosmetic tissues, wet wipes, etc.

#### **Household** waste

Soiled paper (incl. kitchen and paper towels), cleaning sponges, dust bags, small quantities of dishes, cutlery, pots, bowls, drinking glasses, cold ashes, wallpaper, cigarette butts, sweepings, cat and pet litter, pet poop, heavily soiled or damaged clothing and shoes, bags, hats, belts, etc.

### WHAT DOES NOT GO IN THE BLACK CAN?

Plastic packaging without content [see "Yellow bag"]

#### Organic waste

(see "Biodegradable waste") including food leftovers and citrus peels

#### **Construction debris**

Sand, stones, bricks, timber, etc.

#### Hazardous waste

[see "Hazardous waste"] such as batteries, halogen lamps, energy saving bulbs, small electric appliances, asbestos, etc.

### **Biodegradable waste**

The brown can for biodegradable waste will be emptied every 14 days, alternating with the black can for non-recyclable waste. Please place the brown can with the lid closed at the curb before 6 a.m. on the collection day.

Overfilled or incorrectly filled cans will not be emptied.

#### **BROWN CAN**

In Kaiserslautern county, organic waste is disposed of in the brown can and recovered separately.

Unless you have requested home composting (see page 9), you will be supplied with a brown can automatically, together with the black can.

The fee for the brown can depends on the size of the black can: A household of 3-4 persons with a non-recyclable waste volume of 90 liters will pay 27.50 € per year for the brown can [see page 4].

The size of the brown can depends on the size of the allocated black can. For private households, the brown can is at least as large as the black can, with the option of doubling the size on request.

For businesses, the maximum brown can volume is the same as the allocated non-recyclable waste volume.

The following table gives an overview of brown can sizes allocated to private households.

The minimum size is 120 liters.

\* When using a 90-liter black can, the volume of the brown can (that is usually not more than twice the size of the black can) can be increased to 240 liters upon written request (please specify the exact reasons).

Please note: If the extra brown can is provided after the regular waste containers have been supplied, you will be charged a one-time fee of 65.60 €.

#### **ADDITIONAL CAN**

If the maximum brown can size is not sufficient for your biodegradable waste, you can order an extra brown can. Additional yearly fees of 73.68 € for a 120-liter can or 147.36 € for a 240-liter can will apply. The additional brown can must be ordered in writing, either by mail, by e-mail or by fax. The application form can be found on our website.









































To avoid unpleasant smells and maggots in the brown can:



- Wrap organic kitchen waste in newspaper.
- Keep the can in a shady place with the lid closed!

 Use compostable paper bags for biodegradable waste (available in stores).

If an **incorrectly filled brown can** is left unemptied, the items that do not belong in the brown can must be sorted out. Place the can at the curb on the next collection day. An extra collection is not possible in this case!

### WHAT GOES IN THE BROWN CAN?

#### **Garden clippings**

Leaves, grass and hedge trimmings, plants, weeds, etc.

#### Kitchen waste

Coffee/tea filters, paper towels, egg shells, banana and citrus peel, food leftovers including meat and fish, cold cuts, bones, bread, pastries, cheese, vegetables, fruit, etc.

#### Other organic waste

Potted plants with small amounts of potting soil, nut shells, small amounts of wood ash, feathers, newspaper for wrapping leftovers, etc.

### WHAT DOES NOT GO IN THE BROWN CAN?

### Plastic bags and compostable plastic liners

#### **Packaging**

Made of plastic, metal, composite materials, glass, etc.

#### Non-recyclable waste

Diapers, cigarette butts, leather, sweepings, dust bags, hygiene products, pet poop, cat and other pet litter, medication, etc.

#### **Construction debris**

Sand, stones, bricks, timber, etc.

#### Hazardous waste

(see page 18)

#### **ATTENTION**

Dumping the wrong type of waste in the brown can is an administrative offense that may be subject to a fine!







### **Biodegradable waste**

If all your organic waste is composted and used in your garden, you don't need a brown can. In this case the home owner may apply for a reduction of waste disposal fees for home composters.

However, we recommend using the brown can to dispose of problematic leftovers such as fish, meat and bones or clippings with a plant disease.

With home composting, you only save a small amount of money. For a household with 3-4 members it is 27.50 € per year (see waste fee overview on page 4).

#### **HOME COMPOSTING**

**Please note:** To be admitted for home composting, i.e. the re-use of biodegradable waste directly in your own garden, the following requirements must be met:

- correct and safe composting procedures
- composting of the full amount of biodegradable waste
- sufficient garden space (approximately 30 m² per person) to use the entire compost output
- existence of a demonstrable composter with decomposing material

The above requirements may be verified on site. Violations are an administrative offense that may be subject to a fine.

The application for home composting must be renewed whenever the tenant or

owner changes. Otherwise a brown can will be supplied automatically.

If the brown can has been used at the same property for a while and residents now want to switch to home composting, a one-time fee of 65.60 € will be charged.

Application forms are available at your municipal administration and on our website. Written notice is also required if you intend to stop composting. Garden clippings (hedges, branches, grass) can be dumped at the garden waste collection point in your community.

### Yellow bag

Yellow bags will be collected on the same day as non-recyclable waste.

Please place the tied yellow bags at the curb before 6 a.m. on the collection day.

#### **RESPONSIBILITY**

Yellow bags are not distributed and collected on behalf of the Kaisers-lautern county administration. These services are not included in the waste disposal fees.

#### The waste management office of the Kaiserslautern county administration is not responsible for complaints.

The yellow bag is financed exclusively by the dual systems in Germany, which receive a fixed monetary amount for each individual packaging unit sold.

This initiative publishes the services required in relation to yellow bags in calls for tenders and engages bidding companies accordingly. Kaiserslautern county does not have any influence on this procedure. The contracting authority for Kaiserslautern county is from 2025 the dual system "Der Grüne Punkt - Duales System Deutschland GmbH", which has engaged the company Jakob Becker Entsorgungs-GmbH for the distribution and collection of the yellow bags.

#### **BASIC DISTRIBUTION**

A basic quantity of yellow bags is usually distributed in November and December. Each household receives 60 bags. This basic quantity should be sufficient to meet the annual demand.

### Yellow bag

#### WHAT GOES IN THE YELLOW BAG?

#### **Plastics**

Films: e.g. plastic packaging, bags, liners, cling film Plastic bottles: e.g. for detergents,

toiletry, beverages Cups: e.g. for margarine or yogurt [please remove aluminum lids] Foam material: clean styrofoam packaging, foam packaging, e.g. for fruits or vegetables

#### Metals

Packaging made of metals, empty spray cans, food and beverage cans, aluminum (e.g. yogurt cup lids, foil), bottle caps

#### Composite materials

Packaging made of composites, beverage cartons e.g. for juice or milk, coffee packaging, vacuum packs

#### THINGS TO KNOW ABOUT THE YELLOW BAG

- Put items in the bag one by one, not packed in plastic liners.
- Make sure that different materials do not stick together.
- Remove the aluminum foil from plastic cups.
- Only collect empty packaging and wrappings. Packaging containing pollutantfree leftovers are non-recyclable waste.
- Packaging containing residues of harmful substances must be taken to the hazardnus waste truck.

#### WHAT DOES NOT GO IN THE YELLOW BAG?

- Glass, paper, cardboard
- Packaging with (residual) content e.g. spoiled food
- · Foam materials e.g. mattresses, chair cushions
- Records, cassettes, CDs, DVDs
- Plastic pipes
- Insulating foams
- Bicycle tires, water hoses
- Pieces of carpet flooring and wallpaper
- Plastic items or furniture, e.g. chairs, laundry baskets, etc.
- (Synthetic) leather products
- Insulating material (styrofoam, polystyrene)
- Plastic household items and toys, e.g. bowls, buckets, ride-on toys, toilet brushes

#### **ATTENTION**

The yellow bags are for packaging made of plastic, metal or composite materials only.

Any kind of misuse, e.g. as a bag for non-recyclable waste or for the collection of used clothing, is prohibited and may be subject to a fine!































### Waste paper

The blue can for waste paper is emptied every 4 weeks. Please place the blue can with the lid closed at the curb before 6 a.m. on the collection day. Overfilled or incorrectly filled cans will not be emptied.

The blue cans used for the collection of waste paper in Kaiserslautern county have a volume of 240 liters. Usually, each home will be assigned one can. If a

larger volume is required, up to four 240 Loans can be provided on request. In case a home requires more than four cans or there is a great deal of cardboard, a 1.100-liter container can be ordered from the waste management

While 240-liter cans for paper are free of charge, the company providing 1,100liter containers for paper charges a

monthly leasing fee.

1.100-liter containers must be ordered in writing (or by e-mail) because we need a billing address for the monthly leasing fee.

This will be communicated to the container provider.

As an alternative, customers can buy a standard 1.100-liter container and place it at the curb for waste collection. In this case, the Kaiserslautern county administration will empty the container free of charge.

For all matters regarding the blue can, please contact the Allocation division of the Kaiserslautern county administration (see page 32 for contact details).

The container is easier to handle than multiple cans, and bulky cardboard can be dumped more conveniently.

Unlike with 240-liter cans, cardboard boxes do not have to be torn. They can simply be folded to fit into the container.

1,100-liter containers are emptied every 4 weeks on the same day as 240-liter paper cans.

### Waste paper

In **individual cases**, e.g. after a relocation, the volume of your can or container might not be sufficient for your waste paper. In such circumstances you can put waste paper **up to a volume equivalent to your blue can's capacity** in cardboard boxes and place these next to your blue can on the collection day or take the excess waste to the recycling centers in Kindshach or at ZAK.

#### **ATTENTION**

Paper cans and containers are for (clean) waste paper, cardboard and cartons only.

Any inappropriate use of the paper can or container is an administrative offense that may be subject to a fine.

#### WHAT GOES IN THE BLUE CAN?

Newspapers, magazines, catalogues

Books

Cardboard boxes [no beverage cartons]

Wrapping and packing paper (no foil)

#### Paper

Advertising brochures and flyers, letters, envelopes, etc.

(Outer) packaging made of paper or cardboard

> Only clean paper and cardboard may be put in the container!

#### WHAT DOES NOT GO IN THE BLUE CAN?

#### Composite materials

such as beverage cartons go in the yellow bag.

### Wallpaper

goes in the black can.

#### Soiled paper or cardboard

such as parchment paper, pizza boxes, paper towels, used tissues go in the black can.

#### Ring binders

go in the black can.































### Electronic scrap

#### LARGE ELECTRICAL APPLIANCES

Large electrical appliances, gas ranges and refrigeration units are collected upon request. Kindly remember to indicate the type and number of appliances. You will be notified of the pickup date approx. 14 days after your request. Please place the appliances at the curb before 6 a.m. on the collection day.

An application for the collection of electrical appliances can be made by mail, by phone, by fax, e-mail, or via the Garbage Guide app.

### **Electronic scrap**

#### **SMALL ELECTRICAL APPLIANCES**

Small electrical appliances include any electrically or battery powered device no larger than a toaster.

These appliances can be disposed of at the hazardous waste truck ("Umweltmobil") together with other problem waste. Please see the local press, the Garbage Guide app or our website for dates. Alternatively, you can deposit them at the Kindsbach recycling center or at ZAK Kapiteltal.

Small electrical appliances can also be registered for collection alongside large electrical appliances and placed at the curb in a cardboard box.

### Examples of small electrical appliances:

- Small household appliances such as irons, hair dryers or curlers, electric toothbrushes, egg boilers, electric knives, hand mixers, toasters, kettles, telephones, clocks, pocket calculators, fire detectors, flashlights, etc.
- Small power tools such as drills, cordless screwdrivers, grinders, glue guns, soldering irons, etc.
- Small home electronics such as remote controls, cell phones, smart-phones, tablets, MP3 players, radios, headphones, speakers, keyboards, mouse devices, cables, etc.

- Small battery-powered toys
- **Textiles** with electrical components such as light-up shoes or Christmas hats



#### **ATTENTION**

Always remove all removable batteries from your used appliances before disposal. Please see page 17 for information about the correct disposal of batteries. Due to the high risk of fire, appliances with non-removable batteries must be dumped in the hazardous waste storage at the ZAK center for hazardous waste in Kapiteltal.

































### **Bulk waste**

Bulk waste will be collected upon request. Please place your bulk waste at the curb before 6 a.m. on the collection day (the evening before at the earliest) and separate wood from other items. Do not place on private land!

Each household registered for waste disposal can have bulk waste collected free of charge twice a year (up to 5 m³ of bulk waste per pickup). Each collection exceeding the two free pickups will cost 131.71 €. Requests can be made by phone 0631 / 7105-500 or -250, by fax 0631 / 7105-449, by e-mail at sperrmuell@kaiserslautern-kreis.de, via the Garbage Guide app, or by mail. You will be notified of the pickup date in writing approx. 10 days after your request. The wait time between request and pickup is around 3-4 weeks. Alternatively, bulk waste can be dumped free of charge at the recycling centers in Kindsbach or at ZAK Kapiteltal (see also pages 26-27).

### **Household batteries**

According to the Battery Regulation, consumers are required to return used hatteries, accumulators or hutton cells. to the seller.

Non-removable batteries in electric appliances must be disposed of with the appliance (see page 14-15).

Batteries can be returned to the dealer. or taken to the hazardous waste truck. the ZAK recycling center in Kapiteltal or the Kindsbach recycling center, the Kaiserslautern county administration at Lauterstraße 8. Kaiserslautern, or one of the following battery collection points.

When buying starter batteries (e.g. car batteries) consumers are charged a deposit, which is refunded upon return of the battery to the seller. In addition, the hazardous waste truck and the ZAK center for hazardous waste accept used starter batteries free of charge. A refund of deposits is **not** possible in this case.

### Hazardous waste

Hazardous waste includes everything that is harmful for humans, animals and the environment. For reasons of public safety, it is not collected together with other waste. Hazardous waste may under no circumstance be disposed of in household waste containers or toilets.

Private households can drop **small amounts** of hazardous waste free of charge at the hazardous waste truck ["Umweltmobil"] or at the hazardous waste storage of the ZAK recycling center in Kaiserslautern Kapiteltal.

Please see the local press, the Garbage Guide app or our website to find out when the hazardous waste truck comes to your community and where the nearest stop is.

### **Used clothing**

The waste management office of Kaiserslautern county collects and recycles used clothing and shoes. With the assistance of the ZAK recycling center, we cooperate with certified companies to ensure high-quality recycling and reuse of used clothing.



Every waste fee payer in the county benefits from the proceeds of this project.

Dedicated ZAK containers for used clothing and shoes can be found at both county recycling centers.

Alternatively, you can take textiles to the hazardous waste truck or hand them over to the staff of the truck for electronic scrap on the prearranged collection day.

Please donate clean textiles and shoes (in pairs) packed in bags only.































### **Garden clippings**

Many communities of Kaiserslautern county offer collection points for garden waste. These are designated areas were private individuals who live in the county can dump organic waste from their gardens. This service is free of charge.

To ensure high-quality compost, it is essential that collection points are not contaminated by other waste.

- Straw and hay from agricultural use
- Plant parts infested with Cydalima perspectalis (box tree moths)
- · Potted plants with soil
- Rolled turf and sods

Please note: Many garden waste collection points have opening hours and are closed during the winter months.

#### **ATTENTION**

Dumping green waste from the commercial sector or by businesses is prohibited. Garden and park waste can be delivered to the ZAK recycling center for a fee. Dumping garden clippings or banned waste outside the opening hours or outside the collection points, or any infringement of the provisions stipulated herein is an administrative offense that may be subject to a fine.

### Glass containers

Please put the glass without lids, screw caps, or corks, into the designated containers, separated by color. Dumping glass and other waste on or near the containers is prohibited – even if the container is full – and will be penalized as an administrative offense!

Clean and empty non-returnable glass bottles, flasks, and jars.

### WHAT DOES NOT GO IN THE GLASS CONTAINER?

The center is located on the premises of the Landstuhl municipal construction facilities in Kindsbach, Hirtenpfad 65.

Once per month, recyclable materials (up to 0.5 m³ per material type) from Kaiserslautern county can be dumped by private individuals and small businesses who are registered for waste disposal with non-recyclable waste containers of up to 240 liters.

#### **ATTENTION**

Waste exceeding the allowed volume will be rejected by the recycling center staff.

Dumping recycling material at the recycling center outside the opening hours is prohibited and is treated as an administrative offense.

#### **ACCEPTED WASTE**

- Scrap wood, uncontaminated scrap wood such as room doors, wall and ceiling lining – painted or glued, not treated with wood preservers
- Used clothing and shoes no soiled or moldy textiles

- · Laminate, parquet flooring

- Clean plastic films no agricultural films, e.g. silage films!

### **Commercial waste**

# THE CATEGORY OF SO-CALLED COMMERCIAL MUNICIPAL WASTE INCLUDES:

Non-production-related and solid waste generated on business premises, in commercial and industrial enterprises, in schools, kindergartens, hospitals, nursing homes, or by freelancers, such as office waste, heating residues, sweepings, etc. as well as production-related waste that will not be fed into the production cycle.

Companies can choose to take responsibility for recycling their own commercial municipal waste.

Non-recyclable commercial municipal waste must be disposed of in the county's waste management system.

Depending on the quantity of non-recyclable waste generated, the company can choose one or more black cans with a volume 60 l, 90 l, 120 l, or 240 l that are emptied biweekly, or a 4-wheel container with a volume of 1.1 m³, 3.3 m³, or 5.5 m³ that is emptied weekly or biweekly, as arranged.

In accordance with the details given by business operators, the can and container size and the waste fee will be determined on the basis of population equivalents using the corresponding table in the Waste Management Statutes for Kaiserslautern county.

Without joint disposal, the black can for non-recyclable waste has a minimum volume of 60 l.

#### A brown can for biodegradable waste is

not necessary if this waste is composted or re-used externally (proof required). In this case, businesses will benefit from a reduced waste fee in the same way as private households (see table on page 4).

If the business cannot prove that biodegradable waste is re-used, one or more brown cans will be provided depending on the black can size determined.

Contrary to private households, the brown can(s) for businesses may not be larger than the black can(s).

It is possible to request joint disposal for businesses and private households located on the same lot [see pages 4/5].

#### **DISPOSAL USING LARGE CONTAINERS**

Large containers required for waste disposal have to be ordered by the person obliged to register for waste disposal, usually the property owner. Please be sure to use standard containers that are available for lease from a container provider or for sale from a container manufacturer.

The container leasing fee is not part of the waste disposal fee and will be invoiced directly by the provider.

Please note: When disposing of waste in skip or roll-off containers, additional costs will be incurred according to the current ZAK Fee Statutes.

The Kaiserslautern county administration will send you a notification of charges with the fees for collection and disposal listed separately. A bill of lading (weighing slip) issued by ZAK will be enclosed as proof.

### What to do with ...

#### **ANIMAL CARCASSES**

According to the Waste Law, animal carcasses are not considered waste and may not be disposed of in any of the containers provided by Kaiserslautern county. Their disposal is subject to the Animal Carcass Disposal Law. ### ASBESTOS, FIBER CEMENT, ASBESTOS SHINGLES. FACADE PANELS

Avoid generating dust when treating items containing asbestos (e.g. sawing or breaking). The dust can cause cancer. Always have companies with a certificate of competence according to the Technical Rule for Hazardous Substances TRGS 519 remove asbestos products. Such products must be treated as hazardous waste. For more information, please call the Kaiserslautern county administration at 0631 / 7105-408 or -505.

#### **BATH TUBS**

and shower trays of any material will not be collected together with bulk waste. Take these items to one of the recycling centers.

#### **CAR BATTERIES**

According to the Battery Regulation, consumers are charged a deposit when buying starter batteries. The deposit is refunded when the battery is returned to the seller. Alternatively, you can dump car batteries free of charge at the hazardous waste truck or the ZAK recycling center for hazardous waste (no deposits refunded).

#### **CARTIRES**

Should be returned to the dealer. You can drop-off a maximum of 4 tires (with or without rims) free of charge at the ZAK recycling center.

#### CDS/DVDS

can be handed over at the recycling centers or to the hazardous waste truck.

#### **DOORS AND DOORFRAMES**

can be dumped at the recycling centers (see pages 26/27).

#### **DUVETS AND PILLOWS**

Please offer duvets and pillows that are still useable to a charity organization. Alternatively, you can have them collected with bulk waste or take them to one of the recycling centers.

### ELECTRIC STORAGE HEATINGS / NIGHT STORAGE HEATERS

These appliances can contain different amounts of loosely or firmly bound asbestos products. You can check with the waste management office of the Kaiserslautern county administration whether your appliance contains asbestos. Please indicate brand and product type. Phone 0631 / 7105-408 or -505. Be sure to wrap unopened storage heaters in dust-proof film and hand them over at the ZAK recycling center, classified as electrical appliances. Only specialized companies holding a certificate of competence according to TRGS 519 are permitted to dispose of storage heaters. Never open these appliances!

### ENERGY-SAVING BULBS, LED AND HALOGEN LAMPS

are accepted by the hazardous waste truck, the ZAK hazardous waste storage and the Kindsbach recycling center.

#### **EXPIRED MEDICATION**

can go in the black can. Be sure to wrap items carefully to prevent them from falling out of the box and to keep them away from children. Never flush medicine down the toilet!

#### **FIRE EXTINGUISHERS**

#### **FLUORESCENT TUBES**

are accepted by the hazardous waste truck as well as the ZAK recycling center for hazardous waste.

#### **GAS BOTTLES / CARTRIDGES**

are accepted by the hazardous waste truck as well as the ZAK recycling center for hazardous waste. If possible, please return bottles to the retailer for re-use.

#### **GAS RANGES**

are collected with electrical appliances upon request.

#### **LAWN MOWERS**

Take gas mowers to a certified collection point or recycling company recognized according to the End-of-life Vehicle Directive. Lawnmowers that are free of oil and gas can be disposed of at the ZAK recycling center or with the collection of electronic scrap. Electric lawnmowers can be collected with electronic scrap or taken to the recycling centers. Manual lawnmowers are accepted at the recycling centers or can be collected with bulk waste upon request.

#### **OLD VEHICLES, CAR WRECKS, CAR PARTS**

must be recycled by certified companies who are recognized according to the End-of-life Vehicle Directive (see Yellow Pages).

#### **OIL TANKS**

must be disposed of by a certified company. Please see the Yellow Pages / business directories for addresses (look for "Tankreinigung").

#### **PET AND CAT LITTER**

must be put in the black can.

#### POTS, DISHES AND CUTLERY

can be taken in large amounts to the recycling centers in Kindsbach or Kapiteltal. Small amounts go in the black can.

#### **RING BINDERS**

Empty ring binders go in the black can.

#### **SANITARY CERAMICS**

such as toilets, bidets, urinals, or sinks can be dumped at the ZAK recycling center in Kapiteltal or the Kindsbach recycling center.

**SLIDES, NEGATIVES, PRIVATE X-RAY IMAGES** go in the black can.

#### **SYRINGES AND CANNULAS**

must be packed in an impenetrable, firmly closed box and disposed of in the black can.

#### **THERMOMETERS**

**Mercury thermometers** are accepted by the hazardous waste truck. **Digital thermometers** are electronic scrap.

#### **VEHICLE TIRES**

should be returned to the dealer. You can drop-off up to four tires [with or without rims] free of charge at the ZAK recycling center.

**VIDEO / AUDIO TAPES AND FLOPPY DISKS** go in the black can.

#### **WALLPAPER**

goes in the black can or in a gray bag for nonrecyclable waste available in Kaiserslautern county. Alternatively, you can take wallpaper to the ZAK recycling center in Kapiteltal.

#### WASTE OIL

According to the Waste Oil Regulation, dealers of engine and gear oil must take back the amount sold at no cost. Please make use of this opportunity. Household amounts of oil or polluted waste oil as well as oil filters are accepted by the hazardous waste truck or the ZAK recycling center for hazardous waste.
